






Interest Rates


- The Federal Open Market Committee held its third and fourth meetings of 2024 in April and June, during which, the federal funds rate target range was kept at 5.25 to 5.50%. Inflation remains elevated; however, moderate progress towards reaching the Fed's 2.00% inflation objective was achieved
- The Fed also updated its projections for rate cuts to be only 25bps for the remainder of 2024, down from 75bps projected in March

Historical US Prime, SOFR, and Swap Rates






